1. Introduction

The Northern Integrated Family Violence Services (NIFVS) Regional Plan 2013 – 2017 is the third Action Plan for the Northern Metropolitan Region (NMR) and provides a central platform for the work of the NIFVS Strategic Network, the NIFVS Partnership Management Group (PMG) and the member organisations over the next four years. The key priorities aim to engage a broad range of organisations that are committed to addressing family violence. The work is varied and wide ranging as the sector continues to address the spectrum of challenges from prevention of violence before it occurs to ensuring appropriate responses for survivors and perpetrators of family violence.

The priorities and actions in the plan consolidate and extend the important work that has been occurring in the region in response to family violence and reflects the solid progress towards building and sustaining an integrated family violence service system in the NMR.

2. Background

Over the past decade police, courts and community services have worked together to develop an embedded integrated response to family violence, in order to improve the safety of women and children who experience violence and improve the accountability of perpetrators who use violence.

Since the introduction of *Reforming the Family Violence System in Victoria* in 2005, significant measures have been taken to improve the service system response to family violence at a national and state level, including:

- Significant resources provided for coordination and integration of local service systems to address family violence
- *The Family Violence Protection Act 2008*
- *The National Plan to Reduce Violence against Women and their Children 2010 – 2022* (The National Plan)
- *Victoria's Action Plan to Address Violence against Women and Children: Everyone has a responsibility to act 2012-2015* (Victoria's Action Plan)
- Introduction of the *Victoria Police Code of Practice for the Investigation of Family Violence (2010)*
- Improving the response of courts to victims of family violence
- Improving crisis response to victims of family violence
- Improving the response to men who use violence in order to hold perpetrators accountable for their behaviour
- Increased support for Indigenous family violence prevention programs
- Initiatives to educate and promote respectful and non-violent relationships and prevent violence against women

Integrated Family Violence Services in the Northern Metropolitan Region (NMR)

In the NMR, significant resources have been committed to increasing the capacity of services to respond to family violence and to ensure responses are both integrated and coordinated. Many organisations are committed to integration and coordination including:

3. Definition of Family Violence:

Section 5 of the *Family Violence Protection Act 2008* defines family violence as:

- (a) behaviour by a person towards a family member of that person if that behaviour—
- (i) is physically or sexually abusive; or
 - (ii) is emotionally or psychologically abusive; or
 - (iii) is economically abusive; or
 - (iv) is threatening; or
 - (v) is coercive; or
 - (vi) in any other way controls or dominates the family member and causes that family member to feel fear for the safety or wellbeing of that family member or another person; or
- (b) behaviour by a person that causes a child to hear or witness, or otherwise be exposed to the effects of, behaviour referred to in paragraph (a).

Family violence is the use of violent, threatening, coercive or controlling behaviour by an individual against a family member(s), or someone with whom they have, or have had, an intimate relationship. Violent behaviour includes not only physical assaults but an array of power and control tactics used along a continuum, including direct or indirect threats, sexual assault, emotional and psychological torment, economic control, property damage, social isolation and behaviour which cause a person to live in fear.

A person's experience of and responses to family violence will be influenced by their position in relation to power. This is affected by a number of factors including, but not limited to, socio-economic status, cultural background, sexuality, Indigenous status, ability, age and experience of migration.

Notes to definition

The NIFVS Strategic Network recognises that women and children experience the majority of the burden of family violence; that it is overwhelmingly males known to these women and children who abuse them; and that this abuse occurs mostly, although not always, in private.

Family members, consistent with *The Family Violence Protection Act 2008*, can refer to:

- A current or former spouse or domestic partner
- A person who has, or has had, an intimate personal relationship with the relevant person
- A current or former relative; (please see section 10 of the Act re meaning of a relative)
- A child, sibling, extended family (e.g. grandparent, uncle), blended family members (step father, step sibling, in laws) see section 8
- A person with whom the relevant person may have a cultural relationship that is like family members (See section 8 (3) (d) and section 10 (1)(b))
- A carer with whom the relevant person has a dependent and/or independent relationship (see section 8 (3) (h))
- Across all groups of women, it is important to note that women's own, accurate and lived definitions of family violence are often clouded by men's descriptions, excuses and acts of minimisation. Psychological or emotional abuse can be just as harmful as physical abuse. Abuse in a relationship is never acceptable, regardless of the circumstances, and is never the fault of the victim. Abuse is not caused by alcohol, or stress, or by the victim's behaviour. Abuse happens because the abuser wants to control and manipulate the other person. This definition is based on that used in the *DHS Practice Guidelines: Women and Children's Family Violence Counselling and Support Program*.

4. Northern Integrated Family Violence Services (NIFVS)

Key Integration & Coordination strategies

The NIFVS Strategic Network was formed in 2008 and provides a strong platform to sustain cross-sector collaborations, agency partnerships and community engagement required for integration of the family violence service system in the NMR. The NIFVS Strategic Network engages a broad representation of organisations, in order to encompass all services that work with those affected by family violence. Member organisations of the NIFVS Strategic Network come from the following: family violence services, sexual assault services, mental health services, Aboriginal services, drug and alcohol services, family and children's services, disability services, homelessness networks and housing services, Culturally and Linguistically Diverse (CALD) Services, Primary Care Partnerships (PCP) and health services. DHS and DoJ participate in the NIFVS Strategic Network.

The NIFVS PMG is a high-level leadership group of the family violence funded women's, men's, children's and Aboriginal service providers in the NMR, and WHIN. The PMG is responsible for overseeing and guiding the integrated approach to family violence in the NMR and work collaboratively and in partnership to enhance and continually improve family violence service delivery across the region.

The role of the Regional Integration Coordinator (RIC) and the NIFVS Coordination Team is to undertake a regional leadership and support role for the planning and integration of family violence services. The NIFVS Coordination Team is employed by WHIN and funded by the Victorian State Government, DHS.

Our Vision and Mission

OUR VISION: For women and children to live safe and free from family violence.

OUR MISSION: Our mission is to maintain and continually develop the integrated family violence service system in the North, in order to improve the safety of women and children and to hold perpetrators accountable for their use of violence. We will achieve this integration on both strategic and operational levels by:

- Identifying and responding to systemic issues
- Advocating for systemic change, including in response to reviews, reports, legislation, policy and procedures.

5. The State-wide Context

Violence against women is now recognised as the biggest contributor to death, disability and illness in Victorian women aged 15–44 (VicHealth, 2004).

The Victorian Government acknowledges that violence against women and children is unacceptable in any form, under any circumstances and in any community. The Government's vision is for women and children to live free from violence in Victoria and also to feel more confident to report experiences of violence when they occur. The Action Plan, released in October 2012, sets out a plan of action to reduce the incidence of family violence and sexual assault and lessen the impact of family violence on women, children, other family members and the broader community.

The Action Plan is a whole of government document, with the following Ministers' and Offices' endorsement: the Minister for Police and Emergency Services, Minister for Women's Affairs, Minister for Community Services, Attorney General, Minister for Housing, Minister for Crime Prevention, Minister for Corrections, Minister for Aboriginal Affairs and Minister for Local Government.

The Action Plan outlines the future of the family violence reform agenda and the state government priorities. The Action Plan seeks to maintain a more coordinated and integrated approach from government and non-government agencies to support women and children who are experiencing family violence. It recognises the importance of a whole of government approach that gives consideration to prevention, early intervention and response in equal measure.

The Action Plan envisages addressing violence against women and children through three streams:

1. Preventing violence against women and children, by educating to change attitudes and behaviours, to promote respectful non-violent relationships and engaging organisations and communities to promote gender equity and stop violence.
2. Intervening earlier, by identifying women and children at risk of being subjected to family violence and identifying those who are at risk of using violence.
3. Responding through an integrated system, which provides consistent, coordinated and timely responses to women and children who experience family violence to protect and empower them to rebuild their lives, and to hold perpetrators of violence accountable and prevent perpetrators from reoffending.

Through increased regional integration, coordination and local service provision, demonstrated by the change in DHS divisional boundaries, the Government is committed to ensuring that women and children affected by family violence receive consistent, connected support and service. Furthermore, a comprehensive, integrated system that provides consistent, coordinated and timely responses to family violence more effectively holds perpetrators to account by enhancing police and court processes.

The impact of family violence on children is a strong focus of current initiatives to address family violence, with evidence indicating that even when children are not direct victims, exposure to violence can have significant psychological, emotional and behavioural impacts and adverse developmental effects on them, comparable to children experiencing violence directly. As such, The Action Plan is committed to addressing violence against women *and* children and for children to realise their potential and participate fully in all aspects of their lives.

In 2010 the *Victoria Police Code of Practice for the Investigation of Family Violence* (Code of Practice) was implemented. The Code of Practice embeds police protocols for responding to and investigating incidents of family violence across the state in practice. The subsequent police referral process has resulted in significant growth in referrals to specialist family violence services and has become the primary source of referrals for these services. Reported family violence has more than doubled over the past decade; this increased reporting is vital to exposing the full extent of violence against women and children.

6. Melbourne's Northern Metropolitan Region (NMR)

The population of the NMR is 858,895 (Australian Bureau of Statistics 2011), which equates to 16% of the Victorian population; with Aboriginal and Torres Strait Islander people comprising 0.5% of the total NMR population. The NMR covers more than 1,600 square kilometres from inner city parts of Richmond to remote parts of the Kinglake Ranges and contains suburbs diverse in ethnicity, socio-economic status and infrastructure. The seven Local Government Areas (LGAs) are Banyule, Darebin, Hume, Moreland, Nillumbik, Whittlesea and Yarra.

The NMR has three of the 10 Interface Councils, forming the edges of Melbourne, and two of these (Hume and Whittlesea) are identified as growth corridors. This rapid population growth is straining existing infrastructure and highlighting gaps in service delivery.

Victoria Police crime statistics indicate that reported family violence incidents in the NMR have increased from 5054 incidents in 2007-2008 to 8063 in 2011-2012, which is an increase of 60% (Victoria Police Corporate Statistics Family Violence Incidents 2007/08-2011/12).

In 2011–2012 there were 8063 family violence incidents in the NMR, which was an increase of 18.5% on the previous year. Children were present in 34% of these incidents (2,746). In the 8,063 incidents, 33.7% of female AFMs (Aggrieved Family Member) were fearful or very fearful compared to 6.6% of male AFMs. A total of 328 rapes and 924 sex offences were reported to Victoria Police during 2011-2012 in the NMR (Data extracted from LEAP on 21 December, 2012. Produced by Corporate Statistics, Victoria Police). These numbers are expected to increase markedly over the next few years. The incongruence between the sizeable increase in demand and the lack of growth in funding leaves the sector under-resourced, overstretched and unable to meet the demand.

The NMR is recognised for its innovative service models and regional initiatives, which aim to improve the response to women and/or women with children who are experiencing family violence and to ultimately prevent such violence from occurring. There is widespread commitment to integration and coordination across organisations in the region, evidenced by the sustained engagement and participation in service development and coordination. The NMR has a robust history of commitment from local government and non-government organisations to working together to address violence against women and children.

Whilst there are significant achievements and well established structures and partnerships in the NMR, ongoing improvement of service system responses and strong commitment to collaboration and service integration is required. The NMR has clear evidence of existing and emerging demand, issues and gaps in service responses to family violence, which will become a focus for the NIFVS Regional Plan 2013-2017.

7. Northern Integrated Family Violence Services Regional Plan 2013-2017

The planning process

The development of each NIFVS Regional Plan has been a collaborative process with input provided by a broad range of representatives across the region. A process of regular review, reporting and evaluation has been undertaken to ensure that the outcomes contained in each plan have been achieved.

The NIFVS Regional Plan 2013 -2017 was developed through broad sector engagement and provided opportunities for individual service providers to reflect on achievements to date and identify priorities for the next four years. The planning process built on and consolidated the commitment of a diverse range of organisations with varying levels of engagement in addressing family violence.

The structure of the plan

The NIFVS Regional Plan 2013 – 2017 is structured to reflect the current Victorian State Government policy context. As such, the structure of the plan sees a shift from designated priority areas (see previous NIFVS Action Plans) and a move to priority goals conceptualised on a spectrum from prevention to early intervention and response. The three tiered approach to addressing violence against women and children reflects the strong commitment from the North to continued integration and coordination of the service system.

The diagrammatic representation of the NIFVS Regional Plan 2013-2017 is designed to ensure widespread engagement with the plan, and provides a contemporary and strategically relevant platform for work addressing family violence in the NMR. The plan is designed to be easily transferable to individual and organisational work plans.

The intention of the plan

It is intended that the collaborative process undertaken to develop the NIFVS Regional Plan 2013-2017 will support widespread engagement in the content and goals of the plan. The broad strategic focus of the plan is intended to strengthen the integrated and coordinated approach to addressing family violence across the NMR. The NIFVS Regional Plan 2013-2017 reflects the key initiatives of organisations that are members of the NIFVS Strategic Network and although it may not reflect all work/actions occurring in the region, the plan aims to represent the key initiatives, cross-sectoral work and mutual priority goals in the NMR.


