Family Violence Intake Pathways: Victim Survivor (Adult*)

Police may issue a Family Violence Safety Notice and initiate a Family Violence Intervention Order process. They may also initiate a criminal process. If the risk to the victim survivor is high, the police may make a referral to a Risk Assessment Management Panel (RAMP).

Police attend incident

Police conduct preliminary risk assessment. Police refer to: The Orange Door (Hume Merri-bek or NEMA)

If the victim survivor requires an immediate response outside of business hours or refuge, police also refer to:

Safe Steps Family Violence Response Centre

If a child is present, police may also refer to Child Protection or The Orange Door (Refer to Victim Survivor Child Intake pathway for more information).

The Orange Door triages all police referrals, contacts clients and provides comprehensive risk assessment, safety planning., information and support

Safe Steps conducts comprehensive risk assessment and safety planning by phone.

The Orange Door provides episodic or short-term support and can refer to counselling, case management and other agencies/ services as needed.

Safe Steps can support victim survivors to access refuge and can make referrals to regional after-hours service for face-to-face support. Safe Steps also makes referrals for a range of other needs.

Victim survivor attends court# to apply for a FVIO or a variation, or due to civil action taken by police

Support person may access secondary consultation and/ or support the victim survivor to call a family violence service*.
